The EU's 'Privileged Partnerships' with its Neighbours: An Institutional Perspective

Venue: College of Europe, Verversdijk 16, building A, AUD.1, Bruges, Belgium

Since the 1990s, the neighbouring countries of the European Union that could, in principle, join the EU have to varying degrees become more deeply integrated with the internal market. They have also developed or are developing a certain degree of institutionalisation of their relationship with the EU. These 'privileged partnerships' have taken different forms, ranging from bilateral and rather static models to multilateral and dynamic models. Despite their many differences, they face similar institutional challenges which have so far not been examined in depth and in a comparative manner. This is surprising in light of the topicality of the issue at stake: not only is the United Kingdom negotiating its withdrawal from the EU and under considerable time pressure to find a new partnership arrangement, but Switzerland is negotiating an institutional umbrella agreement for its many bilateral agreements with the EU, the three small-sized countries located within the EU's customs territory – Andorra, Monaco and San Marino – are negotiating a framework association, and Turkey is seeking a modernisation of its (partial) customs union in light of the 'frozen' accession process. Moreover, the European Economic Area has in recent years undergone an extensive review process.

In this context, the conference, organised in collaboration and with the support of the Swiss Mission to the EU, will in particular address the following questions:

- which institutionalised arrangements for integration into and cooperation with the European Union were proposed by the EU and/or the third country/-ies, and why has a specific institutional arrangement in the end been chosen?
- what are the major advantages and shortcomings both for the EU and the third country/-ies with regard to the role of the relevant EU *acquis* and EU institutions in the processes of decision-making, monitoring/surveillance, enforcement and dispute settlement?
- what lessons can be drawn from an institutional perspective regarding 'privileged partnerships' between the European Union and its neighbours?
